# 3/ ADDING eufyCam 2

## Add eufyCam 2 to Your Existing System

On Eufy Security app, follow the onscreen instructions to add your Eufy Security devices. Choose **Add Device**, then select **eufyCam 2** to add it to your system.

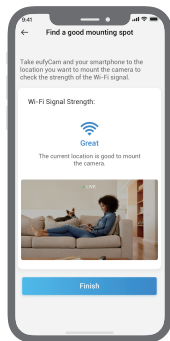


# 4/ MOUNTING THE CAMERA

## Find a Good Mounting Spot

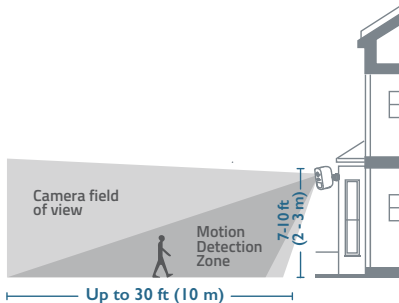
To find a spot to mount eufyCam 2, you need to test wireless signal strength.

- ① Open the Eufy Security app, go to **Camera Settings > Mounting Guide**.
- ② To test the wireless signal strength, take your camera and phone to the location where you want to mount the camera.
- ③ Move the camera as close to your HomeBase as possible if the wireless signal strength is poor.



## Select Height and Location

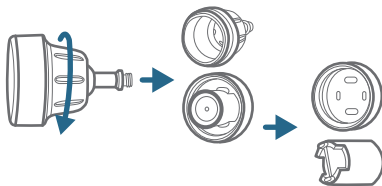
Hang eufyCam 2 7-10 ft (2-3 m) above the ground. This height maximizes the detection range of the motion sensor of eufyCam 2. Avoid placing eufyCam 2 under direct sunlight.



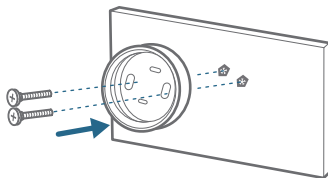
## Mount the Camera Outdoors

Outdoor mount is designed specifically for outdoor environment.

1. Turn the knob of the mounting bracket clockwise to loosen and disassemble it.

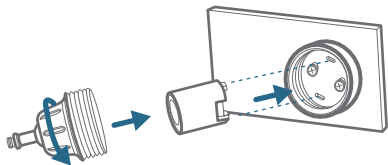


2. Drill holes with a 15/64 inch (5.99 mm) drill bit, then insert the anchors into the holes; anchors are necessary for walls that are made out of hard materials such as concrete, brick, or stucco.

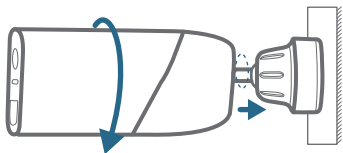


## Mount the Camera Outdoors

3. Firmly screw the base of the mounting bracket onto the wall. Fasten the ball knob of the bracket to the base of the bracket.



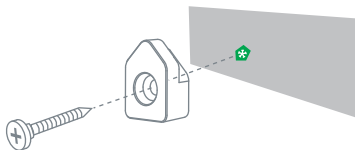
4. Tighten eufyCam 2 camera to the mounting bracket and adjust the viewing angle by checking the live stream feed in the Eufy Security app.



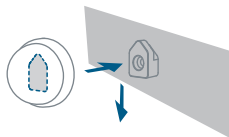
## Mount the Camera Indoors

Stick the camera directly to any flat surface made out of iron. Or you can use the indoor mount to mount the camera:

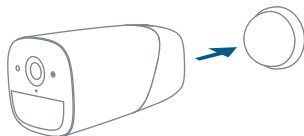
- ① Drill a hole. Use the included anchor if it's drywall and fasten the hook.



- ② Hang the indoor mount on the hook.



- ③ Attach eufyCam 2 to the indoor mount and adjust the viewing angle.

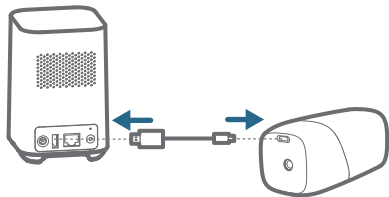

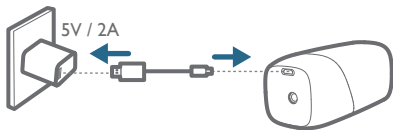
